    The signed report was handed to President Shelly Campbell and the committee was thanked for its work. President Campbell re-read the proposed slate of offices. President Campbell went through the offices of president, vice president, secretary and treasurer in turn and asked for nominations from the floor for each position.     *\*Proposed changes: All arts day increase, concession cart, PTSA Property Enhancements, Teacher and School Grants, Membership Campaign Drive, Stillwater Evening Event, Duvall Days booth, Membership Campaign Drive, & Running of the Balls –*  
    Changes to the line items were reviewed, including All School Arts expense to \$2500, Concessions Cart decrease planned income to \$12 and decrease planned expense to \$100, PTSA Property Enhancements increase expense to \$1200, Playground Equipment increase expense to \$10,500, Stillwater Evening Event increase expense to \$425, Teacher & School Grants increase expense to \$15,167.93, Membership Campaign Drive increase expense to \$400, Stillwater Evening Event Hospitality decrease expense to \$0, Duvall Days booth decrease income to \$0, Duvall Days Booth decrease planned expense to \$250,

Running of the Balls increase income to \$7500 and Running of the Balls increase expense to \$1475. Carmen Love moved to approve the proposed to the 2017/2018 budget. Jen Bauer seconded. None opposed. Motion is adopted.
